3. Supervising Board of General Directors by the Board of Directors:

The Board of Directors of the Company has supervised the Board of General Directors to exercise the rights and duties assigned in accordance with the provisions of law, the Charter of Organization and Operation of the Company (hereinafter referred to as the "Company Charter") and the Resolutions of the General Meeting of Shareholders/Board of Directors, ensuring the legitimate rights and interests of the Company and shareholders.
