RESOLUTION OF THE BOARD OF DIRECTOR

THE BOARD OF DIRECTORS

VIETINBANK SECURITIES JOINT STOCK COMPANY

Pursuant to the Law on Enterprises No. 59/2020/QH14 passed by the National Assembly of the Socialist Republic of Vietnam on June 17, 2020, and its amendments, supplements and guiding documents on implementation;

Pursuant to the Law on Securities No. 54/2019/QH14 passed by the National Assembly of the Socialist Republic of Vietnam on November 26, 2019, and its amendments, supplements and guiding documents on implementation;

Pursuant to the Charter on Organization and Operation, the Company's Internal regulations on corporate governance, Regulations on operation of the Board of Directors of VietinBank Securities Joint Stock Company (the Company/ VBSE);

Pursuant to the Minutes of the Vote counting for Board members' opinions dated June 11, 2026 regarding the Approval of the credit and guarantee facilities at Vietnam Technological and Commercial Joint Stock Bank,

RESOLVED:

Article 1. The Board of Directors (BOD) unanimously adopts the approval of the credit and guarantee facilities at Vietnam Technological and Commercial Joint Stock Bank (Techcombank) in accordance with the proposed contents of the General Director of the Company in Proposal No.62/2026/TTr-TGD dated June 03, 2026, specifically as follows:

- Total credit and guarantee limit: **1,400,000,000,000 VND** (In words: One thousand four hundred billion dong), in which:
 - + Unsecured limit: **1,000,000,000,000 VND** (In words: One trillion dong);
 - + Secured limit: **400,000,000,000 VND** (In words: Four hundred billion dong).
- Limit tenor: 12 (twelve) months from the effective date of approval of credit facility.
- Other details shall be implemented in accordance with Section 1, Part II of Proposal No. 62/2026/TTr-TGD dated June 03, 2026 of the General Director of the Company regarding the submission to the Board of Directors for approval of



the credit and guarantee facilities at Vietnam Technological and Commercial Joint Stock Bank (Techcombank).

Article 2. Implemented organization:

- To assign General Director to execute the loan process and utilize the loan guarantee service at Techcombank to ensure efficiency and liquidity for the Company, while directing relevant units and individuals to implement issues as per Article 1 of this Resolution in accordance with the law, the Charter of Organization and Operation, and the internal regulations of VietinBank Securities Joint Stock Company

Article 3. Enforcement Terms:

- 3.1. This Resolution takes effect from the date of signing.
- 3.2. Members of the Board of Directors, members of the Board of Management, Heads of Departments/Committees/Divisions at the Head Office and relevant Units and individuals at the VietinBank Securities Joint Stock Company shall be responsible for implementing this Resolution.
